

## BOISE COUNTY BOARD OF COMMISSIONERS MONDAY, FEBRUARY 8<sup>th</sup>, 2016 BOISE COUNTY COMMISSIONER'S ROOM **OFFICIAL MEETING MINUTES**

**IN ATTENDANCE:** Chairman Ward, Commissioner Baker, Clerk Prisco, Deputy Clerk Coffelt, Assessor Juszczak, PA Maloney, Solid Waste Superintendent Bottoms, Road & Bridge Superintendent Jones.

**ABSENT:** Commissioner Jackson.

Chairman Ward called the meeting to order and the pledge of allegiance was recited.

**CONSTITUENT INPUT:** None.

**MINUTES:** Commissioner Baker MOTIONED to approve Monday February 1<sup>st</sup>, 2016 official meeting minutes, Boise County Commissioners. Chairman Ward SECONDED; All Ayes.

**DEPARTMENTAL ISSUES:** <u>Solid Waste Superintendent Bottoms</u> presented four bids for 2016 Hauling Licenses. Discussion ensued. Chairman Ward MOTIONED to approve the 2016 Solid Waste Hauling Licenses for Miller Enterprises, Republic Services, Shane's Trash Services and Boise County Sanitation. Commissioner Baker SECONDED; All Ayes. <u>Assistant Treasurer Turner</u> presented documentation for a request of payment of excess funds from tax collections. Chairman Ward MOTIONED to send the excess funds in the amount of \$43,278.21 to Ronald and Donna Phelps from the tax sales that occurred in September 2015. Commissioner Baker SECONDED; All Ayes. <u>PA Maloney</u> gave an update on training she would like to do with the Department Heads, along with a human resources update. <u>Road & Bridge Superintendent Jones</u> gave an update on the rock slide that occurred on Arrow Rock Road this weekend.

Chairman Ward MOTIONED to approve the facility agreements, for the March 8<sup>th</sup>, 2016 election between Boise County and Crouch Community Hall, City of Crouch, Mutual Improvement/Ladies' Auxiliary Club in Horseshoe Bend, Lowman Emergency Services Station in Lowman, Wilderness Ranch Fire House in Wilderness Ranch and Centerville Fire Station in Centerville. Commissioner Baker SECONDED; All Ayes. Road & Bridge Superintendent Jones presented a Road Mitigation Agreement, for snow removal on section of Pearl Road, Boise County to the Board. **INDIGENT:** Chairman Ward MOTIONED to move into executive session for indigent per I.C. 74-206(1)(d), exempt records. Commissioner Baker SECONDED. Roll call vote: Chairman Ward; Aye, Commissioner Baker; Aye. Motion passed unanimously. Coming out of executive session per I.C. 74-206(1)(d), Chairman Ward MOTIONED to sign the release of lien on case 12-12-E. Commissioner Baker SECONDED; All Ayes. Chairman Ward MOTIONED to deny case 15-12-B. Commissioner Baker SECONDED; All Ayes.

**PA ISSUES:** Chairman Ward MOTIONED to move into executive session per I.C. 74-206(1)(f), pending litigation, and per I.C. 74-206(1)(b), personnel. Commissioner Baker SECONDED. Roll call vote: Chairman Ward; Aye, Commissioner Baker; Aye. Motion passed unanimously. Chairman Ward brought the meeting out of executive session per I.C 74-206(1)(f) pending litigation and per I.C. 74-206(1)(b) personnel. No action required, however the Board reserved the right to enter back into executive session later in the day under I.C. 74-201(1)(f) pending litigation, and per I.C. 74-206 (1)(b) personnel.

**CUMO UPDATE:** Representatives from the CuMo Mine gave an update to the Board on what has been happening with the mine, since they last spoke. Discussion ensued.

## MISCELLANEOUS AND CORRESPONDENCE:

- FYI-IAC Adult Misdemeanor Probation report was presented to the Board for review. PA Maloney would like to see an audit or monitoring of this report, due to inconsistency of numbers within the report. Discussion ensued. PA Maloney, Clerk Prisco, Deputy Clerk Heckathorn and the Board discussed the budget for the Community Justice department as well.
- A Request for a Tax Cancelation from the Treasurer/Assessor was presented to the Board for review. Assessor Juszczak and Assistant Treasurer Turner spoke to the Board about the reason for this cancelation. Chairman Ward MOTIONED to approve the request for tax cancelation for Shannon Page, parcel number RP 054000228460, in the amount of \$280.16 to be canceled. Commissioner Baker SECONDED; All Ayes.
- Signatures from the Board on the most recent amended Travel Policy were obtained.
- Two Certificates of Residency were presented to the Board for approval. Chairman Ward MOTIONED to approve the Certificates of Residency, for Jessica Burke and Dace Huston. Commissioner Baker SECONDED; All Ayes.
- The bills/claims were presented to the Board for review and approval. Discussion ensued. Commissioner Baker MOTIONED to approve the bills for February 5<sup>th</sup>, 2016 in the amount of \$124,492.51. Chairman Ward SECONDED; All Ayes.

**ASSESSOR WORKSHOP DISCUSSION:** Assessor Juszczak presented a brief overview to the Board and broke down his staff and their duties. Discussion ensued.

PA ISSUES: Chairman Ward MOTIONED to move into executive session per I.C. 74-206(1)(f), pending litigation, and per I.C. 74-206(1)(b), personnel. Commissioner Baker SECONDED. Roll call vote: Chairman Ward; Aye, Commissioner Baker; Aye. Motion passed unanimously. Chairman Ward brought the meeting out of executive session per I.C 74-206(1)(f) pending litigation and per I.C. 74-206(1)(b) personnel. Coming out of executive session for personnel and pending litigation, Chairman Ward stated for the record that throughout the day, there have been discussions on personnel and pending litigation, in and out of executive session. Discussions have also been had on motions that need to be made to make corrections for Boise County, being under continued budget review and employee based functions. Chairman Ward MOTIONED to reclassify Planning & Zoning legal from the General Fund extraordinary legal, to the Planning and Zoning Department, under professional services, for purposes of clarification and ease of money tracking, in the amount of \$20,000, effective 2-8-16. Commissioner Baker SECONDED; All Ayes. Pertaining to employee based function, Chairman Ward MOTIONED to permanently create an employee relation function, which would be human resources, and move it to be performed by the Prosecuting Attorneys' Office, effective 2-8-16. Commissioner Baker SECONDED; All Ayes. Regarding Community Justice, Commissioner Baker MOTIONED to amend the Community Justice budget to adjust the grant awards from the PT&D Grant from \$12, 000 to \$19,800. R&S renamed Nurturing Families from \$12,000 to \$14,375.94, and amend Community Justice Trail Stewardship to RAC Grant from \$0.00 to \$14,070, effective today 2-8-16. Chairman Ward SECONDED; All Ayes. Chairman Ward MOTIONED to reclassify the line item, legal cases, from extraordinary legal to be put to the PA budget, for purposes of compensation, and cost associated with the creation of the employee relations function, as well as costs associated with the new court Odyssey system, in the amount of \$20,000, effective 2-8-16. Commissioner Baker SECONDED; All Ayes.

Chairman Ward adjourned the meeting until February 16<sup>th</sup>, 2016.
