

BOISE COUNTY BOARD OF COMMISSIONERS FRIDAY, JULY 7TH, 2017 BOISE COUNTY COMMISSIONER'S ROOM **OFFICIAL MEETING MINUTES**

Chairman Ward called the meeting to order and the pledge of allegiance was recited.

PA ISSUES: Chairman Ward MOTIONED to move into executive session per I.C. 74-206(1)(f), pending litigation, per I.C. 74-206(1)(b), personnel, per I.C. 74-206(1)(d), exempt records, and per I.C. 74-206 (1)(a), to hire an employee. Commissioner Jackson SECONDED. Roll call vote: Chairman Ward; Aye, Commissioner Jackson; Aye, Commissioner Baker; Aye. Motion passed unanimously. Chairman Ward brought the meeting out of executive session per I.C 74-206(1)(f) pending litigation, per I.C. 74-206(1)(b) personnel, per I.C. 74-206(1)(d), exempt records, and per I.C. 74-206 (1)(a), to hire an employee; no action required.

CONSTITUENT INPUT: Mr. Rob Blout presented a plaque to the Board from the 2017 Road Rally for appreciation of support that the Board of County Commissioners has shown every year for this event.

MINUTES: Commissioner Jackson MOTIONED to approve the official meeting minutes for Monday June 26th, (Budget Workshops) Tuesday June 27th and Monday July 3rd, 2017 (Special Meeting) as written. Commissioner Baker SECONDED; All Ayes.

DEPARTMENTAL ISSUES: <u>Sheriff Kaczmarek</u> presented a job description to the Board and discussed, this has been tabled until Tuesday July 11th, 2017. A job description for the Forester position was presented and discussed. <u>Emergency Management Coordinator Showalter</u> updated the Board on a Declaration of Emergency that he is working on for the Solar Eclipse taking place on August 21st, 2017. A discussion of removing the miner's bridge from Morse Creek ensued.

BOISE COUNTY POLICIES: None.

CONTRACTS/AGREEMENTS/GRANTS/RESOLUTIONS: The Atlanta Highway District Agreement was discussed. Resolution 2017-34, a Boise County resolution to establish an approval and routing process for all County Contracts, Agreements, Settlement Agreements, Memoranda of Understanding (MOU) and Grants was presented to the Board and discussed. Commissioner Baker MOTIONED to approve Resolution 2017-34; A Boise County Resolution to establish an approval and routing process for all County Contracts, Agreements, Settlement Agreements, Memoranda of Understanding (MOU) and Grants. Commissioner Jackson SECONDED; further discussion ensued; All Ayes. An Agreement for Law Enforcement Services between the City of Crouch and Boise County which was approved on Monday July 3rd, 2017, was presented to the Board and discussed. Chairman Ward MOTIONED to approve and ratify the agreement for Law Enforcement Services between the City of Crouch and Boise County Sheriffs' Office. Commissioner Jackson SECONDED; All Ayes. The contract for roof repairs to the Community Justice Building was tabled.

DEMAND WARRANTS: Three (3) Demand Warrants were presented to the Board for review and approval. Commissioner Jackson MOTIONED to pay Sunward Corporation in the amount of \$1,000.00 for parts for damage repair to the Quonset building in Horseshoe Bend, out of fund number 27-00 and account number 650-00. Commissioner Baker SECONDED; All Ayes. Commissioner Jackson MOTIONED to pay Sunward Corporation for winter damage repair for Quonset building in Horseshoe Bend to include panels, bolts and nuts in the amount of \$2,494.04 after the insurance deductible, out of fund number 27-00 and account number 800-01. Commissioner Baker SECONDED; All Ayes. Commissioner Baker MOTIONED to pay Richard Patterson a refund of overage for Building Permit number 2015-59, in the amount of \$207.15, out of fund number 01-21 and account number 0493-00. Chairman Ward SECONDED; All Ayes.

INDIGENT: Chairman Ward MOTIONED to move into executive session for indigent per I.C. 74-206(1)(d), exempt records. Commissioner Jackson SECONDED. Roll call vote: Chairman Ward; Aye, Commissioner Jackson; Aye, Commissioner Baker; Aye. Motion passed unanimously. Coming out of executive session per I.C. 74-206(1)(d), exempt records, Chairman Ward MOTIONED to sign the release of lien on case number 10-09-D. Commissioner Jackson SECONDED; All Ayes. Chairman Ward MOTIONED to sign the release of lien on case number 10-09-D. Commissioner Jackson SECONDED; All Ayes. Chairman Ward MOTIONED to sign the lien on case number 16-10-B. Commissioner Jackson SECONDED; All Ayes. Chairman Ward MOTIONED to sign the lien on case number 17-06-A. Commissioner Jackson SECONDED; All Ayes. Chairman Ward MOTIONED to sign the lien on case number 17-06-B. Commissioner Baker SECONDED; All Ayes. MISCELLANEOUS AND CORRESPONDENCE:

- An amended letter of reinstatement for Co-Emergency Management Coordinator Roberts per PERSI rules was presented to the Board and discussed. Chairman Ward MOTIONED to approve the letter of reinstatement, an establishment of employment for John Roberts as the Co-Emergency Management Coordinator for Boise County. Commissioner Jackson SECONDED; All Ayes.
- A letter of support for the Emergency Management Services division of Garden Valley Fire Protection District was reviewed and discussed by the Board. Commissioner Baker MOTIONED to sign a letter of support to the Garden Valley Fire

Protection District regarding a grant application for updated equipment. Commissioner Jackson SECONDED; All Ayes.

- Chairman Ward gave a brief update on the Crouch Bridge; the current step should be completed next week. Work is progressing on the access road to the forty (40) acre parcel near Lowman.
- Future Agenda Topics were reviewed and discussed.

BOARD OF EQUALIZATION: Chairman Ward recessed as the Boise County Board of Commissioners and convened as the Board of Equalization.

1:15 p.m. Keily Ann Hazen: Ms. Hazen was not present at time of appeal hearing. A discussion ensued between the Assessors' office and the Board concerning this appeal hearing. Chairman Ward MOTIONED to deny the appeal for the Pharos Foundation (for the record was 45 minutes past the hearing time). Commissioner Jackson SECONDED; All Ayes. Chairman Ward MOTIONED to sustain the Assessors' value on Parcel number RP05411000001B, RP10N04E279000, RP054110000020, RP05411000001A and MH054110000020. Commissioner Jackson SECONDED; All Ayes.

Assessor Juszczak presented three (3) parcels to the Board for review that an amended value be considered by the Board. Chairman Ward MOTIONED that on Parcel number RP06203001034A to change and correct the value from \$78,639 to \$55,127 for the year 2017. Commissioner Jackson SECONDED; All Ayes. Chairman Ward MOTIONED that on Parcel number RP083040000170 that the value be changed from \$261,906 to \$260,842 as presented by the Assessors' office. Commissioner Baker SECONDED; All Ayes. Chairman Ward MOTIONED that on Parcel number RP054050000070 that the value be changed from \$163,438 to \$0.00 for the primary roll as requested by the Assessors' office. Commissioner Jackson SECONDED; All Ayes.

1:45 p.m. Patrick & Terri Greeson: Chairman Ward stated the process that needs to be followed per the Board of Equalization rules for appeal hearings. Clerk Prisco swore in Assessor Juszczak, Appraisers; Kline, Steffen, Bettys and Kirkland. Clerk Prisco also swore in Mr. Patrick Greeson. Mr. Greeson presented his appeal to the Board. The Assessors' office along with appraisers presented their side to the Board. Chairman Ward MOTIONED to change the value on Parcel number RP027010020420 in category #37, from \$63,208 to \$61,653, for a difference of \$1,555.00; to include a change for the Home Owners Exemption value from \$44,674 to \$36,077. Commissioner Jackson SECONDED; All Ayes.

2:15 p.m. Garth Sickles: Mr. Sickles was not present for the appeal hearing. Clerk Prisco swore in the Assessor and Appraisers. Clerk Prisco read onto record the statement by Mr. Sickles. Appraiser Bettys presented facts and findings to justify the value on said property. Discussion ensued. Commissioner Baker MOTIONED to sustain the Assessors' value on Parcel number RP06N05E162450. Commissioner Jackson SECONDED; All Ayes.

Chairman Ward recessed as the Board of Equalization and reconvened as the Boise County Board of Commissioners.
