

BOISE COUNTY BOARD OF COMMISSIONERS TUESDAY, JULY 12TH, 2016 BOISE COUNTY COMMISSIONER'S ROOM **OFFICIAL MEETING MINUTES**

IN ATTENDANCE: Chairman Ward, Commissioner Jackson, Commissioner Baker, Clerk Prisco, Deputy Clerk Coffelt, PA Pittman, Assessor Juszczak, Community Justice Administrator Leader, Sheriff Kaczmarek, Solid Waste/Noxious Weeds Deputy Allred.

Chairman Ward called the meeting to order and the pledge of allegiance was recited.

MINUTES: Commissioner Jackson MOTIONED to approve the minutes for Tuesday, July 6th, and July 7th, 2016, as written. Commissioner Baker SECONDED; All Ayes.

DEPARTMENTAL ISSUES: <u>Sheriff Kaczmarek</u> presented a payroll addition for a reserve deputy that will be used as needed. Commissioner Baker MOTIONED to accept the payroll addition to the Sheriff's reserve program of John Krempa, for the reserve program to participate in the Core program, Sisk program, Contacts program and any volunteer hours. Commissioner Jackson SECONDED; All Ayes. Mr. Steven Yearsley and <u>Road & Bridge Superintendent Jones</u> of the Road & Bridge Department, discussed with the Board a bid for the repairs needed to be done to the Idaho City Shop. Commissioner Baker MOTIONED to approve the RC Hayes proposal for the Idaho City Shop roof to not exceed \$5,555. Chairman Ward SECONDED; further discussion ensued; All Ayes. Mr. Yearsley and Mr. Jones also discussed with the Board requested repairs to the Boise Street Bridge. <u>Planning & Zoning Administrator Canody</u> discussed with the Board the difficulties her department has been having with Mr. Robert Glenn paying the amount agreed upon for the building permit.
