**OFFICIAL SPECIAL MEETING MINUTES**

**IN ATTENDANCE:** Commissioner Jackson, Clerk Prisco, Deputy Clerk Coffelt, Prosecutor Strong, Human Resources Director Schiffer, Emergency Management Coordinator Showalter, Assessor Juszcak.

Chairman Stirm called the meeting to order.

**DISCUSS EXPENSE REIMBURSEMENT/EXPENDITURES UNDER CARES ACT FUNDING:**

Clerk Prisco participated in webinars earlier in the day that concerned the expenditures and reimbursements, documents were presented, and discussion ensued. Payroll expenses for public safety employees, that have been accumulated between March 1<sup>st</sup>, 2020 and September 30<sup>th</sup>, 2020 and the reimbursement possibility for them were discussed. Chairman Stirm MOTIONED to approve the purchase by Mr. Showalter of personal protective equipment for children, to be distributed to the schools, not to exceed an amount of \$3,200. Commissioner Jackson SECONDED; All Ayes. Commissioner Ward MOTIONED to approve the submission of public safety dollars for (reimbursement) under the remaining amount of the County's CARES Act allocation. Chairman Stirm SECONDED; All Ayes.

**BOARD OF EQUALIZATION: APPLICATION OF HOMEOWNERS EXEMPTION:** Chairman Stirm recessed as the Boise County Board of Commissioners and convened as the Board of Equalization. Assessor Juszcak presented documents to the Board concerning changes to four (4) parcels, discussion ensued. Chairman Stirm MOTIONED to apply a Homeowners Exemption to parcel number RPH02130020090 in the amount of \$17,060. Commissioner Jackson SECONDED; All Ayes. Chairman Stirm MOTIONED to apply a Homeowners Exemption to parcel number RP041010010060 in the amount of \$100,000. Commissioner Jackson SECONDED; All Ayes. Chairman Stirm MOTIONED to apply a Homeowners Exemption to parcel number RPH02130010290 in the amount of \$38,760. Commissioner Jackson SECONDED; All Ayes. Chairman Stirm MOTIONED to cancel a value of \$54,782 for parcel number RP08N05E068510. Commissioner Jackson SECONDED; All Ayes. Chairman Stirm recessed as the Board of Equalization and reconvened as the BOCC.

Chairman Stirm adjourned the meeting until the regular meeting of Tuesday, December 8<sup>th</sup>, 2020.
