**SNOWMOBILE TRAIL COST-SHARE AGREEMENTS-UNITS 8A & 8B:** The cost share agreements for the snowmobile trail programs in units 8A and 8B were presented to the Board for review and discussion. Commissioner Twilegar MOTIONED to approve the Cost Share Agreement among the Idaho Department of Parks & Recreation, Boise County, State of Idaho and the United States Forest Service, which includes this time, the cost sharing information. **BROADBAND GRANT PROGRAM REQUEST FOR FUNDS:** A form requesting funds for the Broadband grant program was presented to the Board, review and discussion ensued. Commissioner Twilegar MOTIONED to make a request for funds to the Idaho State Broadband Grant program, in the amount of \$676,056. Commissioner Holmes SECONDED; All Ayes.

**DEMAND WARRANT:** One (1) Demand Warrant was presented to the Board for review, discussion ensued. Commissioner Twilegar MOTIONED to pay Ziplly Fiber in the amount of \$122.28 for phone services in the Horseshoe Bend Annex, out of fund number 01-18 and account number 461-02.
