WHEREAS, due to unforeseen circumstances there are deficiencies in certain line items contained in the "B" portion of the Road Department budget; and


WHEREAS, through economy in other items within that classification of the budget, the Commissioners can meet this exigency without additional money being added to the Road Department budget.


