

**RESOLUTION #99-33**

**A RESOLUTION ADJUSTING THE FY 98-99 BOISE COUNTY BUDGET TO TRANSFER UNSCHEDULED REVENUE TO THE GENERAL FUND CLERK/AUDITOR, PLANNING AND ZONING AND TO THE JUSTICE FUND SHERIFF AND PRISONER BUDGET:**

WHEREAS; Boise County has received unanticipated funds from Recording fees in the amount of \$5,000.00; from Sales Tax and Property Tax in the amount of \$29,000; from Bogus Basin in the amount of \$2,000.00; from BLM in the amount of \$4,500.00; and from Micro Electronics for a refund in the amount of \$2,646.99; and

WHEREAS, Idaho Code Section 31-1605 allows the Board of County Commissioners to adjust the Budget to reflect the receipt of unscheduled revenue from State and Federal Governments, and private agencies; and

WHEREAS, the annual budget procedure has been complied with in making the said adjustment and the budget adjustment shall not result in increased property taxes:

NOW, THEREFORE, BE IT RESOLVED, that the amount of \$43,146.99 be placed in the Boise County General Fund Budget and Justice Fund Budget as follows:
