Applicant Requesting: PURPOSE OF THE COMPREHENSIVE PLAN AMENDMENT HEARING: To consider an amendment to Part 15 of Chapter 8 Public Services and Utilities of the Boise County Comprehensive Plan to read as follows:

15. Follow the policy that new growth shall pay for itself. In order to provide for current levels of fire services and to assure that new growth pays its share; enact an ordinance and enter into an intergovernmental agreement with the Garden Valley Fire Protection District for the collection and expenditure of development impact fees for the Fire District’s systems improvements as identified in the Garden Valley Fire Protection District Impact Fee Study and Capital Improvement Plan (Final Report – April 19, 2023) as Appendix K. Encourage the County to research ways to make this possible.
