

BOISE COUNTY BOARD OF COMMISSIONERS TUESDAY, JUNE 4th, 2024 IDAHO CITY COMMISSIONER ROOM **OFFICIAL MEETING MINUTES**

IN ATTENDANCE: Chairman Tucker, Commissioner Lindstrom, Clerk Prisco, Deputy Clerk Coffelt, Prosecuting Attorney Sosa, Planning & Zoning Administrator Gross, EBCAD Operations Director Adams, Assessor Juszczak, Community Justice Administrator Leader and HR Administrator Britain. **ABSENT:** Commissioner Twilegar

Chairman Tucker called the meeting to order and the pledge of allegiance was recited.

Prosecuting Attorney Sosa let it be known per I.C. 74-208(5), that as Prosecuting Attorney, he has a strict duty that open meeting laws are complied with. I.C. 74-204(1), requires that meetings such as this require proper notice. Notice of meeting and agenda are needed to be posted. The agenda was not posted, but notice of the meeting was posted. Since there was no agenda, certain decisions that the Board would make could not be final. Prosecuting Attorney Sosa did let the Board know they could take constituent input, also could have Executive Sessions, but advised that any final action should not be taken.

CONSTITUENT INPUT: Ms. Jamie Anderson with a group called Move it, spoke to the Board of the group circulating a petition to move the County Seat from Idaho City to Horseshoe Bend. There will be a meeting held at the Garden Valley Library. Discussion of what the County is doing for sites and the monies that were mentioned in previous minutes regarding site purchases.

Ms. Jane Jerome spoke to the Board with concerns of the open public meeting rules and the confidentiality of negotiations. The need for constituent input and having more articles in the paper of notifications of happenings within Boise County, more transparency. Is Idaho City the best place to have the County Seat and has the Board looked at different places within the County.

Mr. Kraig Wees, from Crouch Chamber of Commerce spoke to the Board regarding certain road closures on July 4th, 2024 for a soap box Derby, and also for the fourth of July Parade. Mr. Wees will return for a later commissioner meeting to discuss further with the Board.
